Question 1 How might alteration of the boundary help or hinder the retention or creation of employment and the general economic performance of the area? Question 4 How might alteration of the administrative boundary help or hinder the need to maximise efficiency and value for money in local government? The Ferrybank area and its hinterland draws down four stands of funding as is the present situation; Kilkenny County Council, Kilkenny Leadership Partnership, along with Waterford City & County Council & Waterford Area Partnership, all of which is vital revenue to the local area. Much opoperation between both County Councils has delivered many projects in the past, however Waterford City and County Council has also made many objection to area plans drawn up by Kilkenny County Council which has been a hinder. The local area could be dealt a massive blow in terms of financial loss if the existing county boundary arrangements were to be changed as the area would only recieve funding from only one local authority and not two which is the present situation.

Question 5 How might alteration of the boundary help or hinder the Planning and Development needs, as administered by the local authority, of the community? At present there are many regional bodies in place to see the development of the South-East in a coordinated and joint manner. These bodies already allow for progress to be made whilst also respecting traditional County boundaries and the people living within this area of concern. Question 6 How might alteration of the boundary help or hinder the delivery of effective and accountable democratic representation? Kilkenny County Council has at present 24 seating members representing on average 4,000 people. The loss of this area in question to Kilkenny County Council would see a reduction of the overall representation to 22 members and a reconfiguration to the local authority and lead to confusion to local people. The population that would be disenfranchised from County Kilkenny would for the very first time find themselves in electoral area to which they have no common cause or allegiance.

Question 7 What strengths or weaknesses do you see in current local authority administrative boundary arrangements in the area? The two local authorities have shown some willingness to achieve much needed service provision which have delivered some much needed projects in the past. Howevere Waterford City and County Council have alos lodged many objections to plans often produced by Kilkenny County Council which has seen many negative impacts. An objection was lodged against the construction of the Ferrybank shopping complex by Waterord City Council some years back whilst preventing local employment to take place and to create confidence in the local economy of the area, this was a huge hindrance. The shopping complex which has since been built and is currently vacant, offers to vital services both of which are provided under the remit of Kilkenny County Council, a local area office, a state of the art local library, which is now widely used by residents of South Kilkenny

and all local people want to see local employment being created when the shopping complex is fully functional.

Is there anything else you wish to add? If the current boundary must be moved it should be back the way in favour of Kilkenny County Council and to reunite the whole village of Ferrybank under the control and remit of Kilkenny County Council.
