Question 1 How might alteration of the boundary help or hinder the retention or creation of employment and the general economic performance of the area? All businesses in South Kilkenny are naturally connected to other businesses in Kilkenny, if this area became Waterford, these partnerships would be heavily affected and cease to continue. KCC have built up a trust with the people in the area over generations that they will be looked after. They have implemented many changes which have improved the areas in terms of aesthetics, accessibility, business/retail/residential appeal, financial situation and economic situation. WCC will be unable to build up this connection with the Kilkenny people living in this area as it will simply take far too long and be too difficult an undertaking. This will lead to a disconnection between WCC and the Kilkenny people living there who will be forced to comply to new rules and regulations and be forced to try find and build up new contacts and relat

ionships with a different set of politicians which will prove very difficult on local businesses/people.

This will not happen with WCC as they don't have the funds for it and don't have the knowledge to implement these changes. There would need to be huge research and planning undertaken by WCC if the boundary changed and this would cost money which WCC don't have.

Question 6 How might alteration of the boundary help or hinder the delivery of effective and accountable democratic representation? Currently, South Kilkenny has very strong democratic representation. Altering the boundary would obviously affect this. This would lead to a completely different political scene as there would be a change in the politicians in power as now, rather than having politicians who try to get the best for their area in Kilkenny, they would be looking on getting the best for their area in Waterford. This would lead to different people voting in different ways and it would take a long time before the South Kilkenny region could ever be properly settled and represented with WCC as there would be no-one on the political scene to which the electorate could guarantee would be able to get the best for these Kilkenny people in Waterford.

Question 7 What strengths or weaknesses do you see in current local authority administrative boundary arrangements in the area? In terms of the boundary currently, the arrangement benefits the people of South Kilkenny much more than if they were part of Waterford. There is simply no need for a boundary commission. No one from South Kilkenny has ever complained as they know that what they have is what's best for them and for their lives. Russia were seen as oppressors by the people of Ireland when they tried to seize part of Ukraine, the only difference here is that the people who live in South Kilkenny want to remain part of the same area. The lives of the people living here will be greatly affected.

Is there anything else you wish to add? This arrangement only benefits Waterford. It greatly affects Kilkenny, it's people, it's business, it's sport, it's communities, it's relationships, it's sole. What Kilkenny loses, Waterford gains. The people of Kilkenny would never want to part of Waterford.
