Question 1 How might alteration of the boundary help or hinder the retention or creation of employment and the general economic performance of the area? Waterfords have created nothing and invested nothing in the area of Ferrybank that is already under their control. A hotel that went from being an iconic building to being a massive eyesore casting a shadow over the city. A train statin that wouldnt be out of place in the 1960s. And lets not forget the north quays, rotting away for 30 odd years now. New plans seem to surface every time an election is on the horizon but they never materialise. Question 2 How might the alteration of the boundary help or hinder the identity or cohesion of local communities in the area? Kilkenny people are fully against this land grab. Many people south of the Suir speak ill of their county and city every day. A sad existence. Question 3 How might alteration of the boundary help or hinder delivery of services by local government to ensure that the needs of the local community are met now and in the future? North of the Suir does not have the infastructure to link it to the city. One bridge, no rail and a useless bus service. Moving the boundary will not change this. It should be allowed develop as a small town in its own right not have its resources swallowed up by a city with a history of wastefulness, underdevelopment, stagnation and living in the past. Services can be improved by cooperation between both councils. A boundary move is unnecessary.

Question 4 How might alteration of the administrative boundary help or hinder the need to maximise efficiency and value for money in local government? Waterford have a history of wasting resources so suggesting value for money would be maximised is false. The only money waterford are interested in is the rates from Glanbia and Belview port Co Kilkenny. Waterford had one of the busiest ports in Europe on the north quays and managed to kill 'the goose that layed the golden eggs' through through their unions, hardly efficient. Mabey they want Glanbia, a brand synonymous with Kilkenny, to replace Waterford crystal, who waterford also managed to destroy and sent packing to the czech republic. Kilkenny as a county is well proportioned in terms of size for administration of services from the city in the heart of the county. Unfortunately for waterford they find themselves with a lobsided population in the county and a power struggle between waterford city and Dungarvan. Question 5 How might alteration of the boundary help or hinder the Planning and Development needs, as administered by the local authority, of the community? Planning and development in Ferrybank, Slieverue Glenmore etc needs to be independent of waterford City. There is not the infastructure in place for it to be a functioning part of the city as its linked by a single bridge. This is not Dublin we're talking about. There's plenty of room for development south of the river.

There is ample room inside the ring road for further development which still has 100s of acres of green field sites.

Waterford have not developed sites at the ard ri, north quays or improved the disgraceful plunkett station in years so there is the evidence of a lack of any development.

In fact during the boom the was hardly any development in waterford city as it stagnated while other citys like cork galway and limerick prospered. Even carlow and Kilkenny City have bigger population growth than waterford City. If the boundary was moved it would hinder any appropriate development for the area as Waterford have no intention of developing the area, as they just want to steal the rates.

Question 6 How might alteration of the boundary help or hinder the delivery of effective and accountable democratic representation? There is no vision or positivity in waterford city and for this reason South Kilkenny would be better served staying with Kilkenny, a city and county that has thrived throughout the recession and will continue to do so.
